



Dear Ms. Hook:

I am writing this letter to recommend that Dr. Lynda Baloché receive the Council of Trustees Achievement Award for 2008.

Having reviewed the materials submitted in support of Dr. Baloché's nomination, I am impressed by the breadth of her academic endeavors, the impact her work has already had and its potential for impact far beyond the immediate field of education. Dr. Baloché truly exemplifies an international agent of change.

**Significance:** Dr. Baloché's work on cooperative learning in the classroom has international significance, as demonstrated by her impressive body of published work (some translated) and her modeling of these concepts in her leadership of the International Association for the Study of Cooperation in Education (IASCE). Her work provides very specific skills for teaching cooperative learning to her immediate students, West Chester University colleagues and the many others who read her publications or hear her speak. As students of these teachers learn democratic social processes, they will develop a norm for approaching learning, solving problems, and working with others that will serve them well throughout their years of formal education, in their communities and in their chosen careers. Many businesses and governmental organizations are working hard to instill these skills in their employees; it requires a time-consuming cultural change. Students who have benefited from contact with Dr. Baloché's work will enter their chosen fields far better equipped than previous generations for the challenges of growing interdependence.


**Quality:** The papers I reviewed are clear, concisely written, and consistently further the concepts of cooperative learning. Dr. Baloché is able to take complex and sometimes radical concepts and make them accessible to the general reader. Her very clear, practical examples generalize beyond the classroom. She is clearly able to expand traditional concepts of classroom management to give teachers and students alike a different approach to learning and working with others.

Another clear example of the quality of Dr. Baloche's work is her major contribution to recent accreditation reports. It is my understanding that it is highly unusual for no weaknesses to be cited during this process. Dr. Baloche's excellent writing and ability to encourage cooperation among fellow faculty, administrators and support staff clearly contributed to the positive reception of these reports.

**Originality:** Dr. Baloche's work on preparing educational entrepreneurs is just one of many examples of the originality of her work. The concept of educator as leader/change agent is relatively new; Dr. Baloche displayed originality in conceptualizing the model. She further displayed originality and extraordinary skill in modeling cooperation among faculty disciplines as she developed the 3E Institute Initiative and assessed its success.

Thank you for the opportunity to review Dr. Baloche's work. It was a delight to consider such well-thought-out, well-written documents. Each of Dr. Baloche's contributions (IASCE, accreditation, FIPSE grant work on the Educational Entrepreneur, consensus-driven Council of Professional Education, multiple publications) stands on its own as significant. Together, they represent a truly impressive body of work that will clearly continue to impact the world of education and beyond.

It is an honor to review Dr. Lynda Baloche's materials for the Council of Trustees Achievement Award. Dr. Martha Drobnak's nominating letter accurately summarized the impact of Dr. Baloche's file: "the total picture is, in many ways, much greater than the sum of its parts."

Dr. Baloche has distinguished herself in the discipline of cooperative learning in several respects. The file attests to her considerable leadership in the IASCE (International Association for the Study of Cooperation in Education)—within the organization itself and in the international arena. She has made scholarly contributions through several international conferences and publications—Singapore, Cyprus, Torino, Italy and Nagoya Japan. Her exceptional book, *The cooperative classroom: Empowering learning*, has recently been translated into Chinese. What defines all of this is an ability to bridge the theory and practice of cooperative learning in original and creative ways that speak to teachers at all levels of education. As Dr. Drobnak describes, "She is certainly a respected national and international researcher, author and presenter in the area of cooperative learning."

I particularly appreciated how Dr. Baloche extends her commitment to cooperation in her collegial role at West Chester University. Her contribution to the FIPSE grant, her leadership within the NCATE accreditation process and her commitment to the Council of Professional Education through shared governance speak to living by her word and her values. Dr. Drobnak defines her as a "facilitator" who "encourages cooperation among fellow faculty members, administrators and support staff to achieve a common goal."

West Chester University has a wonderful opportunity to recognize a scholar who has become a recognized leader in her discipline internationally as well as an academic who cares deeply about the organization within which she lives and works. The file represents a significant collective body of work in the area of cooperation. Her work is particularly original in how it integrates the creative processes at every level.

I recommend that Dr. Baloche be awarded the Council of Trustees Achievement Award. This is a wonderful opportunity to recognize someone who uses a wide range of leadership skills dedicated to cooperative values at every level of education. The Trustees of West Chester University are to be commended for creating this opportunity for its faculty. Dr. Baloche meets the criteria with distinction.





Dr. Sterling E. Murray

Dr. Murray has been a revered and formative teacher at West Chester University for 35 years. His many students over the decades have been greatly touched and affected by his pedagogical skill and commitment. Dr. Murray's commitment to his students extended well beyond the classroom. He was faculty advisor to the Sigma Rho chapter of the national music fraternity, Phi Mu Alpha Sinfonia, for many years, played clarinet alongside students in local performances, and led many student trips abroad. Trips to Oxford, England, were made under the aegis of the WCU Institute for British Cultural Studies, which he founded and directed from 1989 to 1999. The Oxford Program, which continues to this day, represents only one example of Dr. Murray's curricular initiative.

Dr. Murray's other curricular initiatives include the many revisions and improvements of the graduate and undergraduate programs made during the years he served as department chair (1993-2007).

Dr. Murray's service to the School of Music has been exemplary in other ways, as well. He was Coordinator for Graduate Studies in Music from 1988 – 1990, and served as Interim Dean from 1992-1993.

As for his contributions to his field, Dr. Murray has also excelled well beyond the norm. He is an internationally-recognized scholar of 18<sup>th</sup> century German instrumental music, and has published six books and some 21 articles on the subject. His eminence in the field is capped by his founding and subsequent presidency of the international Society for Eighteenth-Century Music from 2001-2005.

This record of achievement is matched by research interests in other areas as well. His ongoing concern with pedagogy is the source of two other of his books – *Anthologies of Printed Music: An Annotated Index*, a bibliographical guide to existing music anthologies that has gone to two editions, and his *Teachers' Manual for Listen by Joseph Kerman*, a thorough-going pedagogical outline for one of the most widely-used music appreciation textbooks. His third area of scholarly activity, musical life in 18<sup>th</sup> century America, has also resulted in six articles, some of which have appeared in prestigious journals like *Journal of the American Musicological Society* and *Musical Quarterly*, as well as a significant number of review and presentations. He has also co-edited a book on Renaissance mannerism, a subject lying well outside his main research areas.

Clearly, Dr. Murray's achievement as a teacher, scholar and administrator is exemplary, and he is wholly deserving of the conferment of emeritus status.

Dr. Mary Ann Maggitti

Dr. Maggitti's career at West Chester University spanned thirty-seven years. Over her long career, she held many positions and served West Chester University with dedication and integrity. Her contributions in teaching, administration and service are many.

Involved in a research program in the late 1960's and early 1970's under the U.S. Department of Education fighting the "War on Poverty", Dr. Maggitti began her career at West Chester State College to help create better educational opportunities for young children and their families living in poverty. In 1970, she began working on Project COPE, a demonstration model for a comprehensive preschool program for children from low-income families. From 1970 to 1975, she was responsible for developing the model program and collecting program evaluation data. Along with that, she developed and taught the curriculum designed to prepare the parents as classroom aides in preschool programs. Her knowledge and talents opened doors for her to move to positions of increasing responsibilities.

From 1975-1977, Mary Ann served as Training Coordinator for Project COPE. She was responsible for the national dissemination of Project COPE's model through educational materials and training seminars. During this time, she was also active with Project CHILD which was a joint effort between West Chester State College and the Chester County Intermediate Unit to provide in-home services for children with learning disabilities and their families.

Through her tenure at West Chester University, in addition to her full-time faculty position, Mary Ann also held the following positions: Associate Director of the Child Studies Group, Assistant to the Provost, Coordinator for NCATE reaccreditation preparation, Chair of the Department of Childhood Studies and Reading where the undergraduate and graduate programs were among the largest in the University. In 1995, Mary Ann was asked to serve as Interim Associate Provost, and she served effectively in this position for two years. A reorganization of departments within the School of Education took place in 1997. Mary Ann joined the early childhood faculty as part of the Department of Early Childhood and Special Education. From 1998-2000, she also served as chair of the University's Council on Academic Policies and Curriculum (CAPC). In 1999, she was asked to serve as Interim Associate Dean for the School of Education. In 2004, Mary Ann became the Coordinator of the early childhood program's off-campus degree completion program for T.E.A.C.H. scholarship students in Philadelphia. The last five years of her career were dedicated to excellent teaching and advising in the early childhood program in the College of Education. During this time, as part of the University's NCATE reaccreditation application, she wrote the Specialty Program Area Report submitted to the National Association for the Education of Young Children (NAEYC). This report was posted to their website as an example for other early childhood programs around the nation preparing for an NCATE review.



In addition to her teaching and administrative roles, Mary Ann was active in service to the University and also committed her time and expertise to community service. Her University service includes: service on CAPC for thirteen years; service on the Tenure, Evaluation and Promotion Committee for two years; service on numerous department and university search committees, the PeopleSoft Advising Committee, departmental evaluation committees, Chair of Teacher Education Council, Chair of the School of Education Space Management Committee, and the University Academic Advising Council among others.

Dr. Maggitti has been successful in each position that she has held in the University. Given her strengths in teaching, advising, administrating, service and her tireless dedication commitment to West Chester University, she is truly deserving of the emeritus designation.

Dr. Dennis R. Klinzing

Dr. Klinzing's commitment to West Chester University, his colleagues and his students spanned an impressive thirty-one years. During that time, he clearly established himself as a person of character, principle and integrity who assumed numerous leadership roles campus wide.

Under Dr. Klinzing's serving as chairperson of the Department of Speech Communication and theatre Arts (subsequently the Department of Communication Studies), fifteen current tenure track members were recruited and hired spanning great academic, geographic, and cultural diversity. In addition to serving as chairperson, he taught, and in several cases developed, ten courses on both the graduate and undergraduate level, served on countless committees, had leadership in professional organizations (including President of the Pennsylvania Speech Communication Association and founder of the Health Communication Interest Group for the eastern Communication Association), published two books (one which was translated into Italian and Danish) and delivered sixteen professional presentations between 2001 and 2006. Dr. Klinzing personifies the teacher scholar model of excellence.

The tenured and tenure-track faculty of Department of Communication Studies unanimously extended their strong support for Dr. Klinzing to receive the emeritus designation. During his tenure, he led by example, provided wise council, mentored faculty and students within the department, and he also put the theoretical principles of conflict resolution, intervention and mediation to work within the larger university community.

His accomplishments, his dedication to students and faculty, his collaboration with colleagues and departments, and his commitment to enhancing the global vitality of West Chester University are all evidence of a professional life that exemplifies and defines Professor Emeritus.




