

BE IT RESOLVED THAT THE COUNCIL OF TRUSTEES OF WEST CHESTER UNIVERSITY OF PENNSYLVANIA HEREBY APPROVES THE RENAMING OF THE HEALTH FEE TO THE HEALTH AND WELLNESS FEE. THE HEALTH AND WELLNESS FEE SUPPORTS ALL HEALTH AND WELLNESS RELATED ACTIVITIES SUCH AS THE HEALTH CENTER, COUNSELING CENTER, AND OTHER WELLNESS CENTERS AND/OR PROGRAMMING/EDUCATIONAL NEEDS FOR STUDENTS.

BE IT RESOLVED THAT THE COUNCIL OF TRUSTEES OF WEST CHESTER UNIVERSITY OF PENNSYLVANIA HEREBY APPROVES AN INCREASE OF \$3.29 PER SEMESTER TO THE HEALTH AND WELLNESS FEE. THE NEW FEE OF \$222.01 PER SEMESTER IS APPLICABLE FOR BOTH UNDERGRADUATE AND GRADUATE STUDENTS EFFECTIVE THE FALL 2024 SEMESTER.

PARKING AND TRANSPORTATION FEE (formerly Parking Improvement Fee)

BE IT RESOLVED THAT THE COUNCIL OF TRUSTEES OF WEST CHESTER UNIVERSITY OF PENNSYLVANIA HEREBY APPROVES THE RENAMING OF THE PARKING IMPROVEMENT FEE TO THE PARKING AND TRANSPORTATION FEE. THE PARKING AND TRANSPORTATION FEE COVERS ALL EXPENSES RELATED TO MAINTAINING EXISTING PARKING FACILITIES (INCLUDING GARAGES AND PARKING LOTS) AND THE SHUTTLE BUS CONTRACT, ALL OF WHICH BENEFIT WEST CHESTER UNIVERSITY'S STUDENT POPULATION.

BE IT RESOLVED THAT THE COUNCIL OF TRUSTEES OF WEST CHESTER UNIVERSITY OF PENNSYLVANIA HEREBY APPROVES AN INCREASE OF \$14.45 PER SEMESTER TO THE PARKING AND TRANSPORTATION FEE. THE NEW FEE OF \$110.52 PER SEMESTER IS APPLICABLE FOR BOTH UNDERGRADUATE AND GRADUATE STUDENTS EFFECTIVE THE FALL 2024 SEMESTER.
